### **Settlement of Disputes:**

Any disputes concerning implementation of programs will be settled amicably through consultation or negotiation between the two institutions.

#### **Amendment:**

The MoU may be amended or revised at any time by mutual consent of the two institutions and such amendment shall form an integral part of this MoU.

#### **Duration and Termination:**

The MoU shall enter into force on the date of signing.

The MoU shall remain in force for a period of five (5) years and may be extended for another period by mutual written consent of both the institutions. Either institution may terminate this MoU at any time by giving written notification to the other institution.
